Mayor Laginess has called a Special Council meeting for 4:30 PM on Wednesday, February 22, 1995. The purpose of this meeting is to present and discuss the proposal from Sheriff Gilbert for providing law enforcement for the Town.

Mayor Laginess, Attorney McInnis and I met with Sheriff Gilbert on Friday to discuss law enforcement for the Town. Apparently, I misunderstood Under-Sheriff Alford when he presented his proposal with the numbers and the \$33,000 price is for one (1) deputy for eight (8) hours, five (5) days a week. (A little different than I was led to believe!)

This deputy would be dedicated to the Town, the Town would set his work schedule and he would do what the Town required, however, he would remain an employee of the Sheriff's Department.

The cost of the vehicle and equipment remains \$17,000.
