✓ A Motion was made by Councilman Laritz to pay \$50,000.00 for a trunk line to a lift station at the Cinco Bayou Bridge, seconded by Councilwoman Booher. Motion carried. The money is to be borrowed from Food Fair and payments not to exceed cigarette tax collected from Food Fair and interest not to be over 4%.

The Minutes were read and a Motion was made by Councilman Peek and seconded by Councilwoman Booher that they be approved. Motion carried.

A Motion was made to accept the Finance Report, as read, by Councilman Laritz and seconded by Councilwoman Booher. Motion carried.

Motion made by Councilman Laritz, seconded by Councilwoman Booher, to place the 19 street lights recommended by the committee carried.

Mayor Gibson stated that the town had received a "thank you" from the Department of Transportation for their interest in the escape route.

✓ Clearing of underbrush in Glenwood Park will continue after the area has had time to dry.

The six month audit July-January, 1970, will be held for another month.

Motion to adjourn made by Councilman Laritz, seconded, so carried.
