3 APRIL 2000

Mayor Drabczuk called the Special Town Council Meeting to order at 12:00 P.M. to review the resumes from the candidates applying for the position of Town Manager/Clerk.

Councilwoman Carroll proposed to offer the position to Nell Webb on a temporary basis for a certain number of days with the understanding that if she was not satisfied or if the Council was not satisfied she would be able to return to her present job of Administrative Assistant. There was a discussion between the Council members about Nell's qualifications. Councilman Frucci disagreed with the offer. Nell was asked to return to the meeting at 12:10pm. The Council members decided to come up with a short list of the top five applicants. Councilman Frucci noted that some of the candidates were in Councilwoman Carroll's homeowners association and ask her if there would be a conflict of interest. She replied "no".

A motion to narrow the list to the top three people for interviewing purposes was made by Councilman Payne and was seconded by Councilwoman Carroll and passed unanimous.


