SPECIAL COUNCIL MEETING  
July 20, 1978

Town officials in attendance: Mayor Jim Kendrick, Council members Phil Johnston, and Ralph Perry; Attorney Rick Powell and Recorder Dee Rouse. Absent: Council members Irene Balsley, Harold Peek and Max Usrey-On Vacation.

Also present were: Miller Burt-Polyengineering, Karen Ann Patterson-Sea Scaping Construction Company, Representative from Barksdale Marine Contractors and Representative from EMCO, Inc.

Mayor Kendrick opened the meeting for bids on the Francis Park Seawall at 5:30 p.m.

Engineer Miller Burt read the following bids:

1. SOULE CONSTRUCTION COMPANY, INC., of Pensacola, Florida:
