1. Attorney Anchors gave the first reading by title of Ordinance No. 188, which adopted a 2.3 millage rate. Councilman Farley made a motion to approve the ordinance as read. Councilman Carol seconded the motion. The motion passed unanimously without discussion
2. Attorney Anchors gave the first reading by title of Resolution No. 2002-01, which proposed an operating budget for fiscal year ending Sept 30, 2002 in the amount of \$357,590. Councilman Carroll made a motion to approve the ordinance as read. Councilman Farley seconded the motion. The motion passed unanimously without discussion.

Adjourn – There being no further business, the meeting adjourned at 6:05 p.m.



Mrs. Betty Jordan of Jordan & Associates was introduced to the Vision Group. She introduced engineer Joseph Mittauer of Mittauer & Associates. Mrs. Jordan gave a presentation on the CDBG (Community Development Block Grant) breaking the grants down to four main areas: Housing, Neighborhood Revitalization, Commercial Revitalization and Economic Development.

The meeting was recessed at 5:59 pm for a public hearing. The meeting was re-adjoined at 6:05 pm



Adjourn – There being no further business, the meeting adjourned at 7:12 p.m.


