PUBLIC HEARING

1. Mayor Farley read by title the first reading **RESOLUTION 2010-07: A RESOLUTION OF THE TOWN OF CINCO BAYOU, FLORIDA, OKALOOSA COUNTY, LEVYING THE ADVLOREM PROPERTY TAX MILLAGE RATE FOR MUNICIPAL PURPOSES ON ALL TAXABLE PROPERTY WITHIN THE TOWN FOR THE FISCAL YEAR BEGINNING OCTOBER 1, 2010 AND ENDING SEPTEMBER 30, 2011 STATING THE PERCENTAGE BY WHICH THE MILLAGE TO BE LEVIED IS LESS THAN THE ROLLED-BACK RATE; AND, PROVIDING AN EFFECTIVE DATE.** Councilman Artabasy made a motion to adopt RESOLUTION 2010 - 07 setting the Millage Rate for the Fiscal Year October 1, 2010 Through September 30, 2011 to 2.1000 mills per \$1000. 2. Mayor Farley read by title the first reading **RESOLUTION 2010-08: A RESOLUTION OF THE TOWN OF CINCO BAYOU, FLORIDA, OKALOOSA COUNTY, ADOPTING THE GENERAL OPERATING BUDGET FOR THE TOWN OF CINCO BAYOU, FLORIDA, FOR THE FISCAL YEAR OCTOBER 1, 2010 THROUGH SEPTEMBER 30, 2011.** Councilman Koch made a motion to adopt Resolution 2010 - 08 adopting the General Operating Budget for Fiscal Year October 1, 2010 Through September 30, 2011 in the Amount of \$1,025,849. Councilman Artabasy seconded the motion. A roll call vote was taken:
