1. Council action to Adopt Resolution 2013-04 for the Proposed Millage for the FY 2013 / 2014 to be Set at 2.3500 mills per \$1,000 on the Taxable Property within the Cinco Bayou Town Limits.

RESOLUTION NUMBER 2013 - 04

A RESOLUTION OF THE TOWN OF CINCO BAYOU, FLORIDA, OKALOOSA COUNTY, LEVYING THE AD VALOREM PROPERTY TAX MILLAGE RATE FOR MUNICIPAL PURPOSES ON ALL TAXABLE PROPERTY WITHIN THE TOWN FOR THE FISCAL YEAR BEGINNING OCTOBER 1, 2013 AND ENDING SEPTEMBER 30, 2014 STATING THE PERCENTAGE BY WHICH THE MILLAGE TO BE LEVIED IS MORE THAN THE ROLLED-BACK RATE; AND, PROVIDING AN EFFECTIVE DATE.
