

FINAL PUBLIC HEARING
MILLAGE and BUDGET FY 2012/2013
CINCO BAYOU TOWN COUNCIL
SEPTEMBER 20, 2012 ♦ 5:30 PM

Mayor Farley called the second and final public hearing for Fiscal Year 2012/13 Millage and Budget to order at 5:30 P.M. on Thursday, September 20, 2012. Following a moment of silence and Pledge of Allegiance, roll call was taken:

PUBLIC HEARING:

1. Attorney Burns read by title Resolution 2012-02: *A RESOLUTION OF THE TOWN OF CINCO BAYOU, FLORIDA, OKALOOSA COUNTY, LEVYING THE AD VALOREM PROPERTY TAX MILLAGE RATE FOR MUNICIPAL PURPOSES ON ALL TAXABLE PROPERTY WITHIN THE TOWN FOR THE FISCAL YEAR BEGINNING OCTOBER 1, 2012 AND ENDING SEPTEMBER 30, 2013 STATING THE PERCENTAGE BY WHICH THE MILLAGE TO BE LEVIED IS LESS THAN THE ROLLED-BACK RATE; AND, PROVIDING AN EFFECTIVE DATE.* Councilman Artabasy made a motion to approve Resolution 2012-02 which sets the millage rate for Fiscal Year 2012/2013 at 2.3500 mils. Councilwoman Hood seconded the motion. A roll call vote was taken:

2. Attorney Burns read by title Resolution 2012-03: *A RESOLUTION OF THE TOWN OF CINCO BAYOU, FLORIDA, OKALOOSA COUNTY, ADOPTING THE GENERAL OPERATING BUDGET FOR THE TOWN OF CINCO BAYOU, FLORIDA, FOR THE FISCAL YEAR OCTOBER 1, 2012 THROUGH SEPTEMBER 30, 2013.* Ms. Dykes clarified that the budget was amended to reflect grant charges that occurred in FY 11/12. Councilman Bratton made a motion to approve Resolution 2012-03 which sets the budget in the amount of \$1,000,155 for Fiscal Year 2012/13. Councilwoman Driver seconded the motion. A roll call vote was taken:



The motion passed unanimously.


There was no public input.
