

RESOLUTION 2012-01

A RESOLUTION OF THE TOWN COUNCIL, OF THE TOWN OF CINCO BAYOU, FLORIDA PROVIDING FOR THE RECOVERY OF EXPENSES INCURRED BY THE TOWN IN PROCESSING APPLICATIONS FOR VARIOUS BENEFITS, APPROVALS AND/OR AUTHORIZATIONS UNDER THE CODE OF ORDINANCES OF THE TOWN.

WHEREAS, there are numerous provisions under the Code of Ordinances for the Town of Cinco Bayou, Florida (the "Town"), that provide the opportunity for citizens and land owners within the Town to apply for certain benefits, approvals and/or authorizations by the Town; and,

WHEREAS, in the course of processing applications under the Code of Ordinances of the Town, the Town incurs certain expenses which are necessary to properly complete the procedures applicable to various provisions of the Code of Ordinances which are ultimately for the benefit of the applicant seeking the benefit, approval and/or authorization and should not be an expense to the Town and its residents; and,

WHEREAS, the Town Council finds that it is in the best interest of the Town and its residents to make provision for the recovery of expenses incurred on behalf of applicants to the Town for certain benefits, approvals and/or authorizations under the Code of Ordinances for the Town.

NOW THEREFORE, BE IT RESOLVED BY THE TOWN COUNCIL OF THE TOWN OF CINCO BAYOU, FLORIDA, that the Town Council hereby adopts the following resolutions:

1. That the Town Manager shall develop an estimate of expenses/charges to be incurred by the Town in the processing of applications under the Code of Ordinances for various benefits, approvals and/or authorizations depending upon the nature of the application and the processes required under the Code of Ordinances to complete consideration of the application request. These expenses/charges shall include, but are not limited to, the public hearing and other public meeting advertisement cost, and any other costs/charges associated with obtaining the benefit, approval or authorization.
2. That in addition to any application fees as currently required by the Code of Ordinances for the Town, the Town Manager shall also cause to be collected from applicants for any benefits, approvals and/or authorizations under the Code of Ordinances the estimated expense total for the particular application being filed and such amounts shall be paid by the applicant in advance to the Town before any action is taken by the Town in furtherance of the application.
