1. Council action of setting the FY 2020/2021 final Millage at 3.0000 mills per \$1,000 on the Taxable Property Within the Cinco Bayou Town Limits. Town Attorney Jeff McInnis read Resolution No. 2020-03:

**RESOLUTION NUMBER 2020 - 03**

**A RESOLUTION OF THE TOWN OF CINCO BAYOU, FLORIDA, OKALOOSA COUNTY, LEVYING THE AD VALOREM PROPERTY TAX MILLAGE RATE FOR MUNICIPAL PURPOSES ON ALL TAXABLE PROPERTY WITHIN THE TOWN FOR THE FISCAL YEAR BEGINNING OCTOBER 1, 2020 AND ENDING SEPTEMBER 30, 2021 STATING THE PERCENTAGE BY WHICH THE MILLAGE TO BE LEVIED IS MORE THAN THE ROLLED-BACK RATE; AND, PROVIDING AN EFFECTIVE DATE.**

1. The ad valorem property tax millage rate for municipal purposes to be levied on the taxable property within the Town limits of the Town of Cinco Bayou, Florida, during the fiscal year beginning October 1, 2020, and ending September 30, 2021, is hereby set at the rate of 3.0000 mills.
2. The percentage by which this millage rate to be levied is MORE than the rolled-back rate of 2.9201 mills (computed pursuant to Florida law) is 2.74%

2. Council action on setting the FY 2020/2021 Town of Cinco Bayou General Fund Budget at \$721,901.00. Town Attorney Jeff McInnis read Resolution No. 2020-04:

**RESOLUTION NUMBER 2020 - 04**

**A RESOLUTION OF THE TOWN OF CINCO BAYOU, FLORIDA, OKALOOSA COUNTY, ADOPTING THE GENERAL OPERATING BUDGET FOR THE TOWN OF CINCO BAYOU, FLORIDA, FOR THE FISCAL YEAR OCTOBER 1, 2020 THROUGH SEPTEMBER 30, 2021.**

The General Operating Budget ( 721,901.00 ) for the fiscal year ending September 30, 2021 is hereby adopted by unanimous decision of the Town Council of the Town of Cinco Bayou, Florida, without objection, at a public hearing held after due notice of the same. This is an increase of 7.8 % of the previous year's budget.


