Town Manager Keith Williams requesting consideration from the CRA (COMMUNITY REDEVELOPMENT AGENCY) to purchase new lights for the Eglin Parkway Corridor not to exceed \$62,000 including freight and storage. We will have a second public hearing to discuss the installation labor and storage costs.

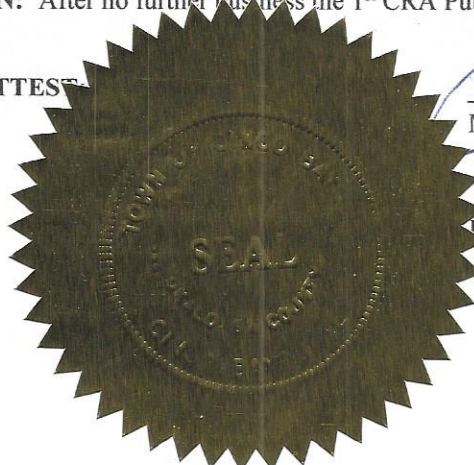


